



## Student Rights and Responsibilities Hearing Board – Student Application

We are pleased that you have decided to apply to serve on the Student Disciplinary Council (SDC). The University-wide SDC is a volunteer group made up of faculty, students and staff involved in helping resolve alleged violations of the EWU Student Code of Conduct. Helping uphold Eastern Washington University's (EWU) student conduct code is one of the most thought-provoking and rewarding ways you can serve our community. SDC members play a critical role in adjudicating student conduct matters. SDC members are trained to serve and are contacted throughout the year on an as-needed basis to hear conduct cases.

### Eligibility to Serve:

- Student representatives must be current undergraduate, graduate or professional students at Eastern Washington University.
- Students must be enrolled, in good academic standing, and reside near the EWU campus during the duration of their appointment on the SDC.
- If selected to serve on the Council, students will be required to complete all training sessions related to how the Council operates and what is expected of them as a member.
- Students who are not present or actively engaged in the SDC may be released as members.

### Application and Selection Process

Every year, EWU seeks students to serve a (renewable) term of one academic year. This is a highly- regarded position and serving as a student member of the SDC requires demonstrating the utmost level of confidentiality and professionalism.

Student Rights and Responsibilities staff will review applications and select individuals will be invited for an interview, which will be conducted remotely. The Office of the Dean of Students will nominate student representatives to the Vice President of Student Affairs for potential appointment.
